There were not any ARB changes and/or Chief Appraiser changes made to the appraisal roll to approve.



Mark Jamison motioned to not schedule PID's 55647, 93123, 68187, 59258, and 59250, seconded by Cordella Kirkham. Walt Saucier motioned to not schedule PID 230084, seconded by Mark Jamison. Mark Jamison motioned to not reschedule PID 46405, seconded by Walt Saucier. All motions were approved unanimously of voting members.

The board split into panels at 8:30 a.m. to hear taxpayer appeals on matters permitted by Texas Property Tax Code Chapters 41 and 25.
