Minutes of the Regular Meeting of the Liberty County Central Appraisal District Board of Directors held December 14, 2023.

Chairman Bobby Coats called meeting to order at 9:31 a.m.

After establishing a quorum was present, Chairman Coats opened the meeting with the following Directors present:

The board did convene into executive session at 10:17 a.m., as authorized by the Texas Government Code Section 551.071(1)(a)(b), consultation with attorneys; Section 551.072, deliberations about real property; Section 551.074, personnel matter, evaluation of Chief Appraiser; Section 551.076, security matters.
