Minutes of the Regular Meeting of the Liberty County Central Appraisal District Board of Directors held March 21, 2024.

Chairman Mark Sjolander called meeting to order at 9:34 a.m.

The Oath of Office and Statement of compliance with HB490 Section 1 and Section 6.035 of the State Property Tax Code will be administered at next month's meeting for Josh Day.

After establishing a quorum was present, Chairman Mark Sjolander opened the meeting with the following Directors present:

The motion was approved unanimously by the voting members.

Director Bolds motioned to approve the quarterly investment report, seconded by Director Herndon. The motion was approved unanimously by the voting members.

There were not any 25.25 changes to the certified appraisal roll to present to the board.

There were not any taxing unit requests to present to the board to waive penalties and interest on taxing units' quarterly assessments.


Under the Chief Appraiser's report, Chief McCarty informed the board that the first round of notices will be going out soon.

The board did not convene into executive session.


Old business: None
